DOGE, Federal Workforce Cuts Lead to More Homes For Sale in DC, Report Reveals

Housing inventory in the D.C. metro area is up slightly but pending sales have dropped by 6.6% compared to last year, according to Bright MLS.

REALTOR® Sam Medvene, President of the D.C. Association of REALTORS®, attributes this slowdown to federal workforce cuts, tariffs, and overall economic instability.



"I think the current crisis that we're facing is dealing with the federal impact and decision on furloughs and cuts - and the economic uncertainty with the free market," said Medvene. He's also seeing increased buyer hesitancy: "Double-digit clients ended up having to pull out of contracts because they lost their jobs or said, 'This is too big of a decision to really lock in and move forward."

Despite fewer pending sales, home prices remain high, with the median price in April reaching \$655,215 - a 2.4% increase from last year. Medvene advises buyers to stay within their budget: "We are in the storm but it's going to continue over the next six months."

Public Policy Update



DCAR members and clients, led by Bonnie Roberts-Burke, spent the day on Wednesday, May 28th, advocating for common sense reforms to TOPA and fixes to the District's broken eviction process. DCAR representatives also highlighted that the time is now to exempt very small housing providers with 2 to 4 units from TOPA to protect our smallest property owners from abusive buyouts and delays that can last over a year.


