# **DCAR Budget Wins**

D.C. Council Committees have all now adopted their budget reports, recommending changes to the Mayor's proposed budget for the District. These recommendations typically receive substantial deference in the next stage of the budget process when Chairman Mendelson will propose a complete budget for a Council vote on July 14<sup>th</sup>.

Due to the tireless work of DCAR members and staff over the last month, DCAR has secured critical investments and reforms at the Committee stage of the budget process, including eliminating the HPAP Lottery and adding nearly \$2 million to the program.

As the budget process moves forward, DCAR will continue to work to protect these priorities. We will also continue advocating for more investment in homeownership and restoration of the budget sweep from the Real Estate Education and Guaranty Fund, while fighting against any increases in property or real estate taxes.

### **DCAR Advocacy in Action**

Over the last month, DCAR has been advocating at the Wilson Building for investment and reform that strengthens the housing market and addresses the needs of our members, small housing providers, homeowners, and renters.

On Monday, June 9<sup>th</sup>, 2025, Public Policy Committee Chair, Hillary Nash, testified before Councilmember Robert C. White, Jr., advocating for TOPA, eviction, and HPAP reform, promoting investment in homeownership and small housing providers, and defending the Real Estate Education and Guaranty Fund.

On June 18<sup>th</sup>, before Chairman Mendelson, Asia Tyler Morse reiterated DCAR's advocacy on these critical issues and further highlighted the importance of funding for housing and support services for survivors of domestic violence.

Finally, DCAR sent a letter earlier this month to Chairman Mendelson in support of the One Front Door Act of 2025, which would roll back unnecessary regulations and expand the supply of housing in the District.
